When it comes to anticipation, I think perhaps, Spring is like the adult version of Christmas. It is the one season most adults just can't wait to have arrive. I'm pretty sure those warm spring days are just around the corner.

I am guessing most of you are **also** anticipating the long over-due return of your COLA. Congratulations, as a result of your interest, action, and support, the STRS has made the decision to institute a one-time 3% COLA (calculated on your base) to all benefit recipients who are COLA eligible at this time. Furthermore, they promise to review possible added benefit enhancements within the next year. Granted, this is still not the COLA we were promised when we retired, but it is progress, and indicates those in power at the STRS are becoming more aware that their management is under the microscope and that they must be more responsive to their obligation to the state's retirees. I would encourage you to stay mindful, and to remind any former colleagues you encounter, of the fact that this change in the STRS is due in no small part to the advocacy of our state and local ORTA chapters. We must remain diligent in pursuit of this cause and to encourage others to join us, as we have shown that a united front will result in a stronger, better managed STRS Ohio system!

In that same vein, I would encourage you to study the candidates running for a position on the STRS Board. A team of individuals from ORTA has interviewed each of the candidates vying for the Retiree and Active Teacher Representative positions. You can review the Candidate Questionnaire Responses by visiting the ORTA web site (orta.org); scrolling down to the March newsletter link; next, scrolling down to the section that says "Newsletter Viewing"; and then clicking on the link to view the actual newsletter. About half-way through the newsletter, you should find buttons that will take you to each of the candidates' question responses. Having reviewed the responses, ORTA has made "...the decision to endorse three challengers [which] demonstrates ORTA's dissatisfaction with the current leadership in place at STRS. Key themes were increasing transparency and having the board lead the staff, not having the staff lead the board." The endorsed candidates are:

- Retiree seat Elizabeth Jones
- Active seat Julie Sellers
- Active seat Steven Foreman.

Check out the information, make your choice, and make your ballots. Remember, your very important votes need to be received not later than May 2nd.
