Hello and Happy Autumn, Fellow Former Educators!

Many of you who are not currently members of the Highland County Retired Teachers' Association may be wondering why you are receiving the HCRTA Newsletter. Our HCRTA chapter exists primarily as a social and community service organization, providing positive connections among retired educators as well as serving the community through scholarship awards and community service projects and donations. However, our other function is to advocate for retirees' pensions and keep retirees aware of actions at the state level that impact our retirement benefits. Considering the recent publicity surrounding STRS Ohio and the management of our Ohio school pensions, we felt it appropriate to extend an invitation to a much broader audience to attend our next HCRTA General Meeting, scheduled for November 1st at the Pricetown Church of Christ.

Each November we invite STRS to speak to us regarding changes to our STRS Member and Healthcare Benefits. This year in the wake of the Ohio Retired Teachers' Association Forensic Audit, STRS has deemed it appropriate to send their most senior executives to address our group. STRS officials presenting will include Bill Neville, STRS Executive Director, Nick Treneff, STRS Director of Communications, and Gary Russell, Deputy Director of Member Benefits.

We want to welcome you to be a part of this conversation. The STRS officials will not only **speak** to our group but will also present an opportunity for attendees to **ask the "tough questions"** you have regarding what is happening with your retirement investments and your withheld COLA's. Please consider joining us for this very important meeting.

Details Please:

The meeting will be held on Monday, November 1, 2021, in the Fellowship Hall of Pricetown Church of Christ. The church is located at 2070 S.R. 131, Hillsboro, OH 45133. There is a wonderful meeting area, and in keeping with our efforts to host our meeting in various areas of our county, this location allows us to showcase the western part of our county. It is only about 11 miles from the center of Hillsboro (about the same distance from Hillsboro as the Old Y Restaurant). From Hillsboro you would take SR 138 west to Danville, then turn right on SR 131. The church will be on the left once in Pricetown. There is ample parking both in the front and the rear of the building and the meeting room can be entered directly either from the front or rear entrance. Plan to arrive between 11:00 AM and 12:00 PM. We will eat at around 12:00 PM and our speakers will begin at 12:30 PM.

The meal will be catered by All Seasons Catering of Leesburg. This service comes with high recommendations. The meal will consist of a choice of Ham Loaf or Lasagna, Potatoes Au Gratin, Green Beans, Tossed Salad, Garlic Bread, Tea or Lemonade, and Apple Cake with Butter Cream Sauce. Cost for the meal is \$15.00. The room is at no cost except for whatever donation we choose to offer the church. Please send your RSVP and money to Doris Pulse no later than Friday, October 22, 2021. The previously mentioned STSR speakers will follow the meal.

Our November service project will be to support Christmas gifts for foster children in our area. Monkey Beans Giving Closet, a 501 (c) 3 organization is designed to help foster children. All money given will go to provide Christmas gifts for the neediest foster children, to be identified by Highland County Children's Services.
