We need officers as well as volunteers to chair or assist the following standing committees: Membership; Legislative; Community Service; Pre-Retirement: Phone Chain; and Scholarship

STRS, ORTA, and ODE News

Articles from Dr. Robin Rayfield in the ORTA Newsletters continue to be interesting. A few items of interest in his news article include:

- The ORTA Forensic Audit of STRS has officially begun. The public records request has been filed and it is anticipated that the forensic audit process will take approximately 4 months.
- STRS is experiencing a good year with nearly 16% earnings in the 1st half of the fiscal year.
- The STRS chief investment officer will retire in April of 2021, to be replaced by the current STRS manager of alternative investments and fixed income.
- The STRS staff appears to be preparing the STRS board for a recommendation that the Assumed Return Rate (ARR) be lowered. If this happens, it could push any discussion of COLA out possibly as far as 2048.
- STRS has the highest individual contribution rate and the lowest employer contribution rate.
- According to the 300 people surveyed, STRS rates high in member satisfaction.

Dr Rayfield continues to bring awareness to how important our vigilance is to the security of our retirement income.
