Necrology

Given that we are not meeting in person, there are no meeting minutes to include and no changes to the last Treasurer's Report, save the above-mentioned scholarship donations. As an executive committee, since we are not meeting, we felt it appropriate to memorialize our former colleagues by including the necrology report in this newsletter. As such, Cindy Eigel reported the passing of the following individuals:

Joe W. Thompson, passed away February 10, 2020. He began teaching at his alma mater, Dawson-Bryant High School (Coal Grove), in Lawrence County, Kentucky, taught history and coached football, basketball, and baseball. He later served as guidance counselor for Hillsboro City Schools and Paint Valley Schools.

Glenn Mervin Armstrong, passed away March 4, 2020. He began his teaching career in 1950, teaching in the Boston, Sinking Spring, and Leesburg schools. Glenn also coached boys' basketball. He retired in 1983 as math instructor and principal at Fairfield High School, Leesburg. Glen continued teaching at Wilmington College and Southern State Community College until 1994. He was a life member of Ohio Education Association, Ohio Retired Teachers Association, and the Highland County Retired Teachers Association.

Harry V. Turner, passed away March 24, 2020. Harry's career with Greenfield Exempted Schools included: New Petersburg, grades 5-6, 1946-1951; Seventh and Eighth Grade Science Teacher, 1951-1958; Assistant Principal, 1959-1965; and Principal of Edward Lee McClain High School from 1966-1979. He retired in1979 after over 50 years of service in education. In retirement, Harry worked for Kenworthy Seed Company, sold real estate, was director of adult education at Laurel Oaks Vocational School, and was executive director of Highland County Chamber of Commerce. He was a member of Highland County Retired Teachers Association.

Sue Carol Goins McConnaughey, passed away April 3, 2020. In her career Sue taught first, second, fifth, and seventh grades during 37 years of teaching in the Hillsboro City Schools.

Eleanor June McCreight, passed away May 4, 2020. She worked as a teacher's aide in Hillsboro City Schools and owned and operated the Bargain Bazaar Consignment Store. She later retired as a pharmacy technician for the Hillsboro Kmart Store

George W. Foltz, passed away May 14, 2020. He served the community of Greenfield in many ways. George was employed at Weller's Plumbing and Heating, and was later self-employed for many years. He also was employed by Greenfield Exempted Village Schools (doesn't say in what capacity) and later retired from Laurel Oaks Vocational School.

Willard R. Parr (not a teacher, but thought he deserved recognition for keeping us all informed about snow days and also supporting many school activities through his broadcasts), passed away May 18, 2020. In addition to being the "Voice of Southern Ohio" for over 60 years, he served the Hillsboro community from 1951 to 1965 as a police sergeant

Donald A. "Sonny" McCoppin, passed away May 24, 2020, (grew up in Leesburg area). Mr. McCoppin began a teaching career teaching and coaching at Ross High School in Hamilton and later taught at Green Hills, Blanchester, and Laurel Oaks Joint Vocational School.

Katherine Frances Sexton, passed away May 30, 2020. She served Lynchburg-Clay School District as a cook for many years.

Janet L. Walker, passed away June 14, 2020. Janet worked for Lynchburg-Clay High School as a cook for 11 years.

Jannette M. Waller, passed away June 15, 2020. Jannette worked at Bright Local Schools as District Secretary for 31 years.

Barbara J. Hilliard, passed away June 18, 2020. Barbara worked at Hillsboro High School as cook for 5 years (in addition to being social worker at Highland County Human Services for 20 years).

STRS, ORTA, and ODE News

One of the topics of discussion at the executive meeting was recent news from STRS. On its web site, STRS Ohio acknowledged that "... the recent stock market volatility may be unsettling for some of our members. [However,] STRS Ohio is a long-term investor with a diversified asset mix and understands that significant short-term market fluctuations will occur periodically." They go on to say that "... Unless the markets recover meaningfully before the end of June, this will be the first fiscal year with a negative return for STRS Ohio's total fund since 2009." They go on to point out that from 2009 until 2019, STRS Ohio's investments have been very strong, averaging +10.44% per year for the ten-year period. They further note that their "broadly diversified asset mix... is intended to achieve the long-term rate of return objectives of the fund (meeting the fund's actuarial assumed rate of return over moving 30-year periods) with an acceptable level of risk."

All of this to say that while the Covid-19 situations have had an impact on the funds backing our pensions, STRS Ohio remains optimistic about the long-term financial prospects for our retirement system.

The March STRS Board Update assured members that member benefit payments would continue as scheduled, and that other services such as applications, education seminars and in-person meetings would be available online or via teleconference.

If you have not been reading the monthly ORTA newsletters, it is always interesting to read Executive Director Robin Rayfield's report after listening to STRS Ohio Zoom meetings. In his June ORTA Newsletter, DR Rayfield stated,

There was some drama that unfolded during the meeting surrounding the budget submitted by STRS staff for approval by the board. The budget contained raises for STRS employees and continued financial resources directed to the investment staff for 'incentive pay'. The discussion on this matter was lengthy (by STRS standards) and resulted in a 6-5 vote to pass the resolution approving the budget submitted. Most of the opposition to the budget focused on the notion that active members pay more and receive less, retired teachers are not receiving their promised COLA, and the budget for education in Ohio was recently reduced. This is the first time that I have witnessed such a division in the board. The vote was as follows: **No votes:** Dale Price (active member), David Gruber (appointed member), Mr. Hunt (alternate for State Superintendent Palo DeMario), Robert McFee (active member), Wade Steen (appointed member) **Yes votes:** Bob Stein (retired member), Rita Walters (retired member), Yoel Mayerfield (appointed member) Carol Carothers (active member), Jeffery Rhodes (active member), Arthur Lard (active member)

As I consider the discussion from the June 2020 STRS meeting, I am encouraged that several members of the STRS board have acknowledged that the current status quo of retirees not receiving what they were promised while STRS employees receive annual increases is no longer acceptable. I believe that the split vote sends a clear message that we cannot continue down the path that we are on. Hopefully, the pressure from retirees, active teachers, and legislators will move the needle and we can look forward to receiving more of what we were promised.

The latest post on the **Support Bob Hottle- giving Lymphoma the boot** @support.bob.hottle · Community Facebook page, posted 7/20/2020 at about 3PM says,

Bob is doing so well and improving everyday! He is off the ventilator. His oxygen levels are doing well. We pray he continues to be able to cough which improves the fluid issue in his lungs.

He started physical therapy today after being on bedrest for 1.5 weeks. He was weak but showed grit! They are letting him eat some soft foods so he gets a fair chance at proving if he does or does not need a feed tube.

We pray for healing so he can return home. We'd like to see him do what he loves again... being on the farm and helping others.

Please pray that his lungs continue to heal, no aspiration occurrences and lots of strength! Thanks you and as Bob always says, "God Bless"!
